Unique Dual Index Kit (289–384) contains unique dual-indexed PCR primers for amplification of indexed Illumina®-compatible NGS libraries. Each unique dual index (UDI) consists of two premixed oligos, which are supplied in a volume of 5 µl in a 96-well plate format and can be used with many of Takara Bio's RNA-seq or DNA-seq kits. Please refer to the kit-specific user manual for instructions on using the indexed PCR primers provided in UDI kit.

NOTE: Prior to use, spin in a tabletop centrifuge to bring the contents to the bottom of the wells.

Quality Control Data

All primers were verified by ESI analysis to have a major peak with a measured molecular weight within 10 Da of the predicted molecular weight.

All primers were functionally tested with first-strand cDNA generated with reagents obtained from the SMARTer® Stranded Total RNA-Seq Kit v2 - Pico Input Mammalian. The libraries were pooled, quantified, and sequenced on an Illumina sequencing platform. No primer resulted in a library with reads 40% above or below the average reads of all libraries. Data was assessed for uniform representation of all the barcodes (CV≤25%).
